Certain poultry producers are required to hold a NSW Food Authority licence to operate. Businesses that operate without the appropriate licence are committing an offence under the *Food Act 2003* and may be prosecuted.

Did you know ... if you are applying to licence a business and do not hold a current NSW Food Authority licence, you can now lodge your application online by going to the online application form link at www.foodauthority.nsw.gov.au (Please note: conditions apply for use of online applications).

Poultry producers that need to be licensed

Under the Food Regulation 2015, food businesses must have a NSW Food Authority licence if they operate a poultry farm as defined under Clause 76 (1) of the Meat Food Safety Scheme (Part 9 of the Regulation).

Poultry farm means any land or premises where birds (being poultry for human consumption) are grown but only if more than 100 such birds are being grown at any time.

Poultry means chickens, turkeys, ducks, squab (pigeons), geese, pheasants, quails, guinea fowl, mutton-bird or any other avian species (except ratites).

Small poultry farms growing up to 100 birds at any time do not need to apply for a licence. However, these businesses must notify their business details to the Authority at:

What do I need to comply with?

- Any business that holds a licence must comply with the Food Regulation 2015, NSW Food Act 2003, and the Food Standards Code.
- A licensed poultry producer must also develop and operate according to a food safety management statement that complies with Standard 4.2.2 of the Food Standards Code. Assistance material is available at www.foodauthority.nsw.gov.au

What do I need to do next?

 Complete this licence application form and return with payment (if applicable) to: NSW Food Authority, PO Box 232, Taree NSW 2430.

The NSW Food Authority has waived the licence application fee and the licence fee for businesses growing fewer than 1000 birds at any time. See page 6 of this form for more information.

- If you are starting a new business or buying a business from another person, you must apply for a licence before you begin operating. A licence is not transferable from one person or business to another.
- **Please note:** This application does not allow you to stock your property. You must not commence any operations until the licence determination has been made and you are issued with a Food Authority licence. However, if you are submitting this application due to a change in ownership of an on-going business, or a change to your business, where the farm has previously been stocked with birds, prior to the licence application, NO eggs or poultry will be permitted for sale.

Processing times

The Authority will review your application **within 10 working days** of receiving your licence application and you will be notified if any further information is required. If your application is complete the Authority will write to you to let you know your licence application has been processed and provide you with a time frame for completion of the licensing assessment that is required.

IMPORTANT NOTES

- If you have more than one premises, copy page 5 and complete for each premises. If the application forms are submitted at the same time only one application fee will be required.
- Please ensure that each page of the application is completed (where applicable) and checked before it is returned, as failure to provide all information or signature(s) will delays processing and issuing of the licence.
