

LIC002: Licence application for a **plant products business**

Food Regulation 2025

Licence requirements

Certain food businesses must hold a NSW Food Authority licence to operate. Licensing ensures a business has the capacity to produce safe food before it is supplied to consumers. Operating without a valid licence is an offence under the NSW *Food Act 2003* and may lead to prosecution.

Plant product businesses that need to be licensed

Under the Food Regulation 2025, Part 7 Plant products food safety scheme, a food business must have a NSW Food Authority licence if they carry out any of the following activities:

- a. grow or harvest berries, leafy vegetables or melons in a cultivated area of 2 hectares or more
- b. wash, trim, sanitise, sort, combine, store and pack berries, leafy vegetables or melons
- c. process fruits or vegetables (where the end product is able to be consumed raw), including trimming, cutting, slicing, peeling or pulling apart
- d. process vegetables in oil
- e. process seed sprouts
- f. extract juice from vegetables or fruits without pasteurising
- g. package plant products
- h. store plant products
- i. transport plant products (complete the *LIC007: Licence application for a food transport business*).

If storing or transporting only berries, leafy vegetables and melons, and not conducting primary production on 2 or more hectares or a processing activity, a food business notification is required in place of a licence.

The plant products food safety scheme does not apply to the handling of food on retail premises, in or from a vehicle from which the food is sold by retail or not intended for sale.

What do I need to comply with?

Any business that holds a licence must comply with the following:

- Food Regulation 2025
- *Food Act 2003* (NSW)
- Food Standards Code
- Plant product businesses (except those listed as excluded below) must develop and implement an adequate food safety program under the Food Regulation 2025 based on Standard 3.2.1 of

the Food Standards Code or Codex HACCP. The program must accurately outline the hazards associated with the food business's operations. Guidance is available from the Food Authority's website at www.foodauthority.nsw.gov.au/haccp

Excluded business are those that:

- only grow leafy vegetables or melons on 2 to less than 10 cultivated hectares. These require a food safety management statement. Further information is located at www.foodauthority.nsw.gov.au/industry/plant-products
- grow or process berries exclusively
- solely store or transport plant products.

How do I get licensed?

- The easiest and quickest way to apply for a **new** licence is by using the online application form located at formsfa.bfs.dpi.nsw.gov.au/forms/11033.
- If you are unable to use the online form or are applying for additional premises or relocation, complete this form and submit via email or post.
- You must not commence operations until you are informed that your licence application has been processed. If you are found operating a business without a licence, enforcement action will be taken.
- Once your application is processed, you will receive a 'pending advice' letter that confirms whether your business can start operating and outlines the next steps in the application process.
- A licensing assessment is required prior to the licence being approved to ensure compliance with the Food Standards Code and Food Regulation 2025. If the assessment is unacceptable, the licence may not be approved and the licence application may be rejected. It is highly recommended that the applicant refer to www.foodauthority.nsw.gov.au/industry/plant-products and www.foodauthority.nsw.gov.au/industry/audits-and-compliance/audits-of-licensed-businesses for information relating to the assessment process and industry sector requirements.

What is the processing time?

Your application will be reviewed within **10 business days**.

Part C: Calculating full-time equivalent (FTE) food handlers

Under the Food Regulation 2025, the licence fee applied to your business is calculated based on the number of full-time equivalent (FTE) food handlers (excludes office staff and delivery drivers). The number of FTE food handlers is used as it accommodates businesses who use part time food handlers in their operations.

To calculate the number of FTE food handlers, add up all hours employees undertake food handling activities during a working week and divide it by a standard full-time working week (e.g. 38 hours).

For example, if a facility has 4 people handling food for 25 hours per week, this equals approximately 3 FTE food handlers.

$$\frac{4 \text{ food handlers} \times 25 \text{ hours per week}}{38 \text{ hours}} = 2.6 \text{ FTE food handlers (round up to 3 FTE food handlers)}$$
