

The use of artificial intelligence for compliance assessment

Artificial intelligence (AI) is helping the Food Authority assess food safety compliance of vehicles and vessels used by licensed food businesses.

Why is the Food Authority using AI?

Using AI for compliance assessment significantly streamlines the process to apply for, add or replace vehicles and vessels on a NSW Food Authority licence.

Where an onsite inspection of a vehicle or vessel would typically be required, taking around 6 weeks to finalise, AI helps us determine compliance much quicker.

Waiting times and the regulatory burden for businesses are reduced, and the Food Authority can reallocate resources to higher-risk activities.

Who is eligible to use it?

New applicants

Anyone applying for a new Food Authority licence who uses a vehicle or vessel in their business will have the option to use the AI function when they complete our online <u>Apply for a Food Authority</u> <u>Licence form</u>.

Relevant businesses include those that transport plant, dairy, egg and seafood products, meat (including game meat and animal food harvesters) and live poultry.

Existing licensees

Those who already have a NSW Food Authority licence can use the AI function when updating information about vehicles and vessels on their licence through the <u>Apply to vary vehicle and vessel</u> <u>information online form</u>.

How does it work?

Instead of waiting for a food safety officer to inspect your vehicle or vessel, applicants upload photographs of it to our online form, which is linked to an AI tool. This tool uses machine learning to determine whether the photos demonstrate compliance with food safety regulations.

Once analysed, data is forwarded to a Food Authority officer for review and determination.

How do I participate?

To participate you will need to be able to take clear photographs and upload them to the relevant form using a computer, tablet, phone or other smart device.

What you need to photograph depends on the nature of your application. The required photographs are outlined below, as well as in the form.

If you're unable to submit suitable photographs after starting the form, you can save your progress and come back to it later. You may also opt out of using the AI assessment at any time.

What data will be collected and who will have access to it?

The information and images you supply will be used to process your application and will be retained in a secure format for reference by the Food Authority. Only Food Authority officers who need the information for processing applications or compliance will have access to it. Information is not shared with any other parties unless authorised by law.

Images and limited data that identifies them will be retained by our technology provider Wild Mouse for continuous improvement of the AI. The images will be deleted when they are no longer required for the purposes for which they were collected.

What happens if the AI fails my application?

The AI does not 'pass' or 'fail' an application. The data will be processed by a Food Authority officer, who will contact you if more information is needed or if there are any concerns.

Can I have the onsite inspection carried out instead?

Yes. If you would prefer an onsite inspection you can opt out of using the AI assessment in the online form and continue completing your application. Please note, an audit or inspection by an authorised officer can take around 6 weeks. Applications using AI can be finalised much sooner.
